

• **TERMS AND CONDITIONS**

**CANCELLATION POLICY:** A \$500.00 cancellation fee will apply if the reservation is canceled up until 7 days prior to rental date. A \$500.00 cancellation fee on one day rentals applies if cancelled within 7 days or less of rental date. Full rental fees will apply if cancelled within 7 days or is for multiple days or major holiday rentals. A reservation may be moved once, within a year period, with at least 48 hours notice prior to the rental.

**SECURITY DEPOSIT:** A minimum of \$1,000.00 for Class C type motorhomes or vehicles, or minimal of \$1,000.00 each for Class A type motorhomes, Honeywagons, Two Room / Hair & Make-up / Wardrobe Trailer, Truck, or Van on each equipment unit is required in the form of a credit card draft at time of confirmation / reservation. This is not a charge and is fully refundable within 48 hours if the motorhome / honey wagon / vehicle / equipment is returned in the same condition in which it left Papa John John's premises. Vehicles returned with damage will be charged \$1,000.00 per day down time until repairs are completed.

**DEPARTURE AND RETURN:** There are **NO REFUNDS OR CREDITS** for early returns of motorhomes/honeywagons/vehicles and/or equipment. Departure appointment times **MUST** be kept, failure to do so may result in delays and/or additional charges. Papa John John's Motorhome Rentals work on a 24 hour clock. Therefore there is no grace period. Vehicles/equipment returned after the due time will be subject to a \$20.00 per hour late fee. Vehicles/equipment returned before or after office hours are subject to a \$75.00 per hour charge. Vehicles/equipment are to be returned to the same locations where they were dispatched unless otherwise noted.

**INSURANCE:** Customer must provide a private insurance binder and must have a minimum coverage of \$100,000.00 / \$300,000.00 / \$100,000.00 and must be received at least 48 hours prior to the departure to the location/production site. The private binder must show PAPA JOHN JOHN'S as the insured and beneficiary. Your insurance agent should send the binder to the fax number listed below. Failure to supply adequate insurance binder will result in Penalty of \$1,000.00 per day and Papa John John's supplying private insurance and actual cost of insurance being charged to Renter/Lessor. Private Insurance must cover 100% of replacement or repair costs of unit being driven by anyone other than, or a **PAPA JOHN JOHN'S** authorized driver.

**THE FOLLOWING ARE NOT PERMITTED IN ANY PAPA JOHN JOHN'S RENTALS: SMOKING, PETS, TOWING, OFF ROAD USE, ATTACHING STICKERS TO MOTORHOME / HONEYWAGON / TRAILERS / TRUCKS / VEHICLES / EQUIPMENT; USE OR TRANSPORTATION OF ANY ILLEGAL SUBSTANCES, TAMPERING WITH ODOMETER, SENSORS, OR GAUGES.** Failure to follow these conditions will result in fines up to the amount of security deposit, plus any additional fees as required.

**ADDITIONAL CHARGES WILL APPLY FOR THE FOLLOWING:** Dumping fees will apply to eliminate foul odors and damage to holding tanks. An additional minimum of \$100.00 cleaning charge will apply for anything not removable in routine cleaning, (food, mud, sand, stains, odors, bugs, etc.) These will be charged without dispute following unit return to base and final inspection.

**PLEASE NOTE:** If an error is detected in the rental confirmation, or it does not match your reservation, please call immediately. We are not liable for any price discrepancy due to typographical errors or miscalculations. Papa John John's cannot guarantee any particular model or floor plan and reserves the right to substitute motorhome models of similar or higher quality. Should a model of lower grade be accepted, liability will be limited to refund of price differential between model paid and model accepted. A renter must be 25 years of age and must have a valid credit card on file and must sign the original contract or proposal agreement. **ONLY** Papa John John's designated personnel, drivers and/or equipment operators may operate, drive, repair or transport Motorhome(s) and/or Vehicles and/or Honeywagon and/or Vehicles/equipment. Papa John John's is a privately owned business and therefore, no union contract shall take precedence over the use and/or operation of equipment in any state. With acceptance of this agreement, that is understood and agreed. Should a Union contract be signed after contract is signed, drivers will revert to Union payroll and rental agreement will stand as signed, including all charges for overtime for units. Cancellation after reservation/confirmation because of a Union contract constitutes Unfair Labor Practices and will result in the entire amount due and payable and non-refundable. Maintenance call outs on Non-Driver rentals will be charged at \$ 300.00 per hour starting at time of departure from Las Vegas base to return to Las Vegas base. Mileage costs will be accrued on all maintenance call-outs. This includes all out-of-town rentals.

**DEPOSIT:** Client will submit a \$1,000.00 deposit per unit (motorhome, honeywagon, vehicle, equipment) and the remaining balance is due upon departure of the unit(s) from the Las Vegas Base. Cancellation within 7 days of the rental will result in a \$500.00 fee per day per motorhome, vehicle, honeywagon, or equipment (excluding delivery fees); cancellation prior to 7 days before rental will result in a \$500.00 fee. Either a \$1,000.00 per unit hold will be placed on a Visa, Mastercard, or \$1,000.00 cash or cashier's check per unit shall act as a security deposit. Final payment of all charges, including driver's wages, must be paid in full at end of rental or within seven (7) days for incidentals, or additional fees of twenty-five (25%) per cent interest per day shall be charged until billing is paid in full. Credit Card charges will incur a 10 % for MC or VI, service fee charge. Individual signer and/or cardholder guarantees full payment personally when corporate card is used. **All charges on final bill are accepted without dispute. ALL** Legal / Attorney fees shall be the responsibility of the Lessee on all disputes or litigation after invoice has been issued and payment has been charged/paid by credit card. All disputes will accrue a fee of \$500.00 per hour or any part thereof with all taxes and fees additional, including but not limited to time spent on telephone with a credit card company/client/attorney/producer/accountant and any others involved in the dispute, time revising invoice, all legal fees starting at inception of dispute, working on said invoice at any time after final billing, and will be billed to credit card as part of the revised invoice. Individual signer guarantees full payment personally when corporate card is used.

**RENTAL INFORMATION:** Client will receive Motorhome and/or Honeywagon and/or Vehicles/Equipment from Las Vegas Base Location on \_\_\_\_\_, 2014, and return the vehicle(s) to the Las Vegas Base Location on \_\_\_\_\_, 2014. Payment is due prior to departure from Las Vegas Base Location. Additional non-disputable charges will apply to Motorhome and/or Honeywagon and/or vehicles not returned in the same condition as received (gasoline, propane, smoking fee, cleanliness, etc.) Generator use charged at \$4.00 per hour. Less than eight (8) hour turn around time on multiple day shoots will result in an additional one day rental charge. Individual signer and/or card holder guarantees full payment personally when corporate card is used. **ALL CHARGES AND CREDITS ARE IN U.S. DOLLARS ONLY. LESSEE IS RESPONSIBLE FOR ALL FOREIGN FLUCTUATIONS OF CURRENCY. LESSEE AGREES TO PAY ALL FLUCTUATION CHARGES IF DIFFERENT THAN U.S. DOLLARS WHEN FOREIGN CREDIT CARD IS USED.**
